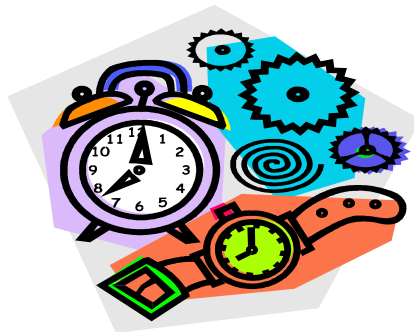
Ladies, if you would like to be considered to work a Walk, please fill out the form and either
