Dear EDWE Friends,

The EDWE Board adopted the following new policy (#1 below) during our recent Policy and Procedure Revision process. The Deadline for determining whether or not the Men's or Women's Walks will be held will be on February 1, therefore we must have the minimum 20 pilgrims for each of the Walks in order for them to be held. Once the minimum number is met, applications will be accepted up to 2 weeks prior to the beginning of each Walk.

Excerpt from the EDWE Policy and Procedure document:

1) Deadline for holding a Walk: The Deadline for the EDWE Board to confirm that a Walk will be held, with the minimum number of Pilgrims required by the Upper Room, shall be 4 (four) weeks prior to the first Walk. (Sept. 9, 2017)

2) Applications: Participants' applications will be accepted up to two weeks prior to the beginning of the walks. (Aug. 11, 2013)

Now is the time for action from YOU, the community. We have known these Walks were happening since last year and the weekend Lay Directors have been working on assembling God's teams since last March. The Board members are praying, the Weekend Lay Directors are praying and the Team members are praying.

NOW, EDWE COMMUNITY MEMBERS, THE WALKS ARE IN YOUR HANDS. You are responsible for sponsoring God's pilgrims and getting their applications turned in as soon as possible. You must listen to God, reach out, and sponsor. Please don't make the Community have to cancel one or both Walks for lack of pilgrims.
